President- Kevin Leach – There has been a lot of misunderstanding from the beginning on what we agreed upon and we have to be more clear on this and move forward from here on. We are here to reconsider the motion that was passed on the 10/13/2016 meeting where a motion was made, seconded and passed to allow one beer per runner only and to runners only.

Vice President – Jack Carroll – There were misunderstandings on what we agreed upon. It is better to have a point by point discussion on what we are agreeing on. We depend on the CCM to sustain the FTC. I respect Carl's opinions, a vote was taken, it is not unusual for a reconsideration of votes. The adults that are running have to be responsible for themselves, there is a risk in what we are doing. The town gave us a permit for the license to sell beer and there will be medical staff at the Beer Garden.

Courtney Bird- We have the best interest of the club at heart, there is validity to both sides with legitimate concerns. We should have explored more carefully in March what we were approving and define what we are approving, we need to define issues before agreeing on them.

Tom Davis- I started investigating on the beer in March, April meeting postponed to May meeting, the September meeting with Cisco initially was to donate 1800 beers to the Beer Garden. The beer was not donated, FTC purchased the beer and since we are a private club, we can determine the pricing of the beer.

Carl Gustafson-There are health concerns in long distance running. I have many concerns on this issue. I am asking the Board to reconsider the original motion.

Helen Kennedy-We have the right to respectively disagree with each other, we are all friends, we have to move forward. We are trying to provide more amenities to the runners, FTC takes pride in what we do and we do it right with safeguards in place, just another amenity.

In my mind, it was not right to do it any other way. I realize and respect that not everyone agrees with my decision.

We currently have 15 Board members. Our newest member excused himself from voting, leaving us with 14 Board members to vote. 10 members were in attendance and voted and 3 members voted via email, and one member did not vote. The results of the vote are shown below:
