

**Falmouth Track Club  
Board of Directors Meeting  
March 27, 2007**

Janet Folger couldn't be there to sell clothing, but she's getting someone else to take her place. Sponsorship money for the race: \$500.00 came in from Lawrence Lynch, we're still waiting on Sherwood Mortgage, Falmouth Physical Therapy made their contribution. It was agreed that someone would talk to Patti O'Brien at Sherwood Mortgage about their sponsorship for this year. Courtney Bird said there were 143 entries to date compared to 113 last year at this date. Courtney estimates we will have 150 pre-registered for the race and 200 at the race. Carolyn will not be at the finish, but has arranged for someone else to do the finish. Ken Gartner is going to do a short article on the race for the Enterprise. We are paying \$300.00 to the girls Falmouth High School cross country team for money we promised them from last year.

Cape Cod Five (CC5) is giving \$2,500, Soft as a Grape has agreed to give us 10% of whatever we spend on T-Shirts. Courtney said he is meeting with the director of Cape Cod Five (CC5). Numbers are up from last year, with 86 registered for the marathon compared to 38 last year and 5 relay teams this year compared to 2 last year. Danielle Brown will be starting full-time in May. She has already started working on the Cape Cod Marathon. Danielle Brown and Nicole Fox are both working at the Cape Cod Marathon booth at the Boston Marathon expo. Danielle is currently paid at an hourly rate.

**Coaching** – Ann reported a light turnout for the workouts. Bob Richards and Glen Rogers have helped out with the coaching. The fields at Falmouth High School are getting better.
